THIS AGREEMENT ("Agreement") is by and between Natural Pet Systems, Inc., dba John’s Natural Dog Training Company (hereinafter referred to as “JNDTC”) and the Owner of the Dog, (hereinafter referred to as “Client”) and entered into for the sole purpose of hiring JNDTC to board or board and train the Clients dog in basic obedience.

Client initials: _____ I certify that Dog is in good health and has not been ill with any communicable diseases within the past 30 days. I certify that my dog has not been exposed to Rabies, Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus, Bordetella (Kennel Cough) Papilloma’s or Conjunctivitis within a 30-day period prior to boarding.

Client initials: _____ I acknowledge that my dogs are trained or groomed, or otherwise handled or cared for by JNDTC or Kamp Kanine personnel without liability on the part of JNDTC’s & Kamp Kanine’s representatives for loss or damage from disease, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, care having been duly exercised.

Client initials: _____ If my dog is found to have fleas and/or ticks when present while boarding, it will be bathed at my expense.

Client initials: _____ I understand, agree and authorize, at my expense, that if in JNDTC’s opinion my dog is in need of medical attention, that medical or emergency services will be sought. I further understand and agree that my veterinarian will also be contacted and JNDTC will proceed per their instructions.

Client Initials: _____ My initials indicate that I certify and agree that all the information I have provided above is true, complete and accurate.

ACKNOWLEDGEMENT OF LIMITATIONS: Client acknowledges and agrees that JNDTC has not represented, promised, guaranteed or warranted that Dog can be trained, that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the training will last for any particular amount of time. Client agrees understands and acknowledges that the elimination or modification of behaviors is not guaranteed. The Client further acknowledges that dog training will not provide exact results as each dog is different in regards to ability, breeding and temperament. Client understands and agrees that follow-up and future training is their sole responsibility and that they must contact JNDTC to schedule future training sessions.

TERMS AND CONDITIONS: For good and valuable consideration JNDTC will provide the following services:

1. **Boarding:** Overnight cage-free boarding.
2. **Board and Train:** Dog shall be boarded and trained at JNDTC's premises or any other location to be determined by JNDTC. Board and Train services includes 2 follow-up private lessons and lifetime admission to Group Obedience Class.

PAYMENT: Client agrees to pay JNDTC a fee for services as follows:

- a. \$50.00 per night boarding fee b. \$25.00 per day training fee c. \$75.00 Non-refundable Deposit

TERMINATION: [REDACTED] (Client initials) JNDTC's services shall terminate if (a) in JNDTC's judgment Dog is dangerous or vicious to JNDTC or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement (c) Client requests service termination. Upon termination in accordance with the foregoing, JNDTC's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

REFUNDS: [REDACTED] (Client initials) If termination for In-Kennel Boarding or Board and Train services occurs, Client shall be entitled to a credit for unused boarding nights, or unused boarding and training services less any expenses, towards future boarding or training services based upon JNDTC's current fee schedule. Deposit fee is non-refundable.

HOLD HARMLESS: The client will hold JNDTC its owners, agents, employees, volunteers, subcontractors and associates including Kamp Kanine free and harmless from any and all claims, liability, damage, loss, or expenses arising out of any injury to any person or to any person's property by the dog(s) named in this contract.

RELEASE OF LIABILITY Client understands that JNDTC and Kamp Kanine are cage-free facilities and as such will play, eat, interact and sleep with other dogs and that there are inherent risks associated with dogs boarding in this environment including but not limited to injuries due to normal play, rough play, scuffles, fights and attempts to escape and run away despite JNDTC best efforts to minimize such risks. Client further understands that despite the best care boarded pets are susceptible to and can develop loose stools, severe diarrhea, hot spots, weight loss, weight gain and excessive shedding. Client agrees to fully release from liability JNDTC, its owners, agents, employees, volunteers, subcontractors and associates should their dog become injured, gets fleas, ticks or worms, becomes pregnant, escapes or runs away, or contracts any malady, illness or disease during or after all services provided by JNDTC, on or off JNDTC Premises, at Clients Home or Business or any other location including Kamp Kanine. Client fully accepts these risks and agrees that JNDTC shall not be held responsible for it or any resulting injuries, losses, damages, costs or expenses.

ARBITRATION: In the event a dispute shall arise between the parties to this Agreement, it is hereby agreed that the dispute shall be referred to The American Arbitration Association. The situs of the hearing shall be in the County Of San Diego for arbitration in accordance with The American Arbitration Association Rules and Procedures. The arbitrator's decision shall be final and legally binding and judgment may be entered thereon. Each party shall be responsible for its share of the arbitration fees in accordance with the applicable Rules of Arbitration. In the event a party fails to proceed with arbitration, unsuccessfully challenges the arbitrator's award, or fails to comply with the arbitrator's award, the other party is entitled to costs of suit, including all reasonable attorneys' fee for having to compel arbitration or defend or enforce the award.

SOLE AGREEMENT: This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and JNDTC regarding the matters as described on Page 1 of 2 and on Page 2 of 2. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to the Dog or anything else.

CLIENT SIGNATURE AND AUTHORIZATION: I have read, acknowledge and agree to all terms, conditions and legal provisions as set forth on pages 1 of 2 and 2 of 2 which represents this entire agreement. My initials and signature on page 1 and 2 of this agreement are proof of my acceptance of this entire agreement. I agree to pay promptly, in full and prior to my dogs stay with JNDTC and after for any additional incurred charges. I will be solely responsible for payment of any charges incurred for any veterinary care and treatment. I further authorize John's Natural Dog Training Company to charge my credit card if it was provided as payment for services. This agreement has no time limit and is valid and enforceable for any and all future stays for my dog(s) with JNDTC unless my information or my dog's information has changed in which case it is my sole responsibility to notify JNDTC of any changes.
